## PAYMENT INFORMATION

The fee for legalisation is 200,- SEK for each document.

For return by registered mail 120,- SEK extra within Sweden, and 150 SEK for Norway, Finland and Estonia. International stamp coupons are not accepted.

## TRACKING OF RETURN LETTERS

### Legalisations by registered mail

If sending your application by registered mail, please do not call the consulate to check if the letter has arrived. Track it yourself on [www.postnord.se](http://www.postnord.se) by the tracking ID.

After the letter has been picked up by the consulate, please allow 7 working days for the legalisation to be made and posted back.

If you need the tracking ID of the return envelope, please do not call. We are unable to give out tracking ID information by phone. Send us an e-mail request with the following information:

- The date the letter was picked up at the post office by the consulate, or arrived at the courier address.
- Your name and address on your return envelope

Mail sent by normal post to or from the consulate can not be tracked at all.
