

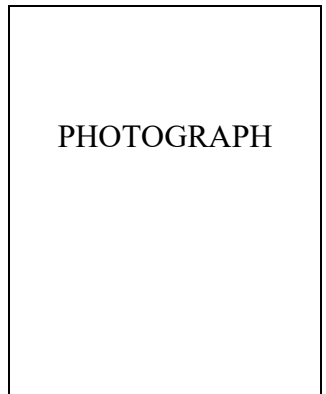

VISA TERMS and APPLICATION CHECKLIST

Application:
I have filled in and signed 1 (one) visa application
1 (one) passport size photo is glued, taped or stapled to the form. (I have not used a paper clip, and the photo is not loose inside the envelope) No paper clips please 
I have attached the passport in original, valid for at least 2 months after the trip to Cameroon
For Business Visa , I have enclosed a letter of invitation from a Cameroonian company or letter of Introduction from Nordic company
I have included page 2 (this page) of the application form together with the items above.
I have read the information on the news section of www.cameroonconsulate.se carefully as it provides up to date information which may not be present on the visa application form.

Payment, choose one option below
For payment by internet bank or Plusgiro. I have enclosed a copy of the payment receipt
For payment in cash. I have enclosed the exact amount in Swedish kronor. (Euro, NOK and other currencies are not accepted)
I have made a payment by Swish (available in Sweden only) and put my name as the message.

Choose the way you will deliver your visa application:
I will send the application by registered mail to the postal address.
I will send the application by DHL Express to the postal address. I understand that no other courier companies will deliver to the postal address – only DHL Express . If sent by a company, an approval is needed that the letter will be redirected to a DHL Service Point.
I will personally drop off the application at the Consulate Mailbox in Brottbý.

The return: Choose one option below and prepare the return envelope.
Return by post – arrange a pre-paid label for registered mail by PostNord for the return. It can be ordered online here: https://portal.postnord.com/skickadirekt/ Please print and attach the label securely to an envelope and enclose together with your application. For more information follow the instructions on the Consulate website at "How to order return labels". The consulate is not able to print the label for you if you provide a receipt or QR-code instead. If you put any amount of normal stamps on the return envelope, it will be posted back to you by normal mail – it will not be registered and will not get a tracking code. Not even if you write REK on it by hand. Norwegian and Finnish stamps do not work at all for the return from Sweden. International stamp coupons are not accepted.
Return by DHL - include a pre-paid DHL Express label for the return or send the label to the consulate by email. The label can be ordered here: https://expresseeasy.se/ You do not need to send a DHL envelope, the label is enough.
Personally pick up from Consulate mailbox. Include a return envelope with your name and a mobile phone number for notification by sms when the visa is ready to pick-up.

Express visa:
I have read the express visa instructions and booked an appointment with the Consulate. I will inform the consulate by email of the tracking ID number if sent by registered mail or by DHL.

Important terms: The visa is valid from the date of issue. The visa must be used within three months from the date of issue. The consulate will not put future dates in the visa. After you receive the passport back, you must check so you have a correct and valid visa before your trip. If the visa needs to be corrected, the consulate will do so, but cannot take responsibility for any upcoming costs. The consulate does not take any economic or other responsibility if the passport should be delivered late by post or courier.

Tracking of letters to and from the Consulate

Visa application by registered mail

If sending your visa application by registered mail, please do not call the consulate to check if the letter has arrived. Track it yourself on <http://www.postnord.se/> by the tracking ID. The same for tracking ID of the return. Since you have ordered the label for the return you can track it by the ID.

Please note: If you have put normal stamps on the return envelope, it will be posted by normal mail. It will not be registered and will not have a tracking code.

Visa application by DHL Express

If sending your visa application by DHL Express, please do not call the consulate to check if the letter has arrived. Track it yourself on <https://www.dhl.se/exp-sv/express/godssoekning.html> by the tracking ID. The same for the return.
